1. Minutes:

It was moved by Phyris, seconded by Lou, and approved by all that the Minutes of the September 9, 2020, Zoom Board Meeting are approved.

2. Treasurer's Report:

Bill distributed the Financial Statement for October to the Board by email prior to this meeting.

- **3. Donation to Redwood Credit Union Community Fund:** It was moved by Phyris and seconded by Bill to approve the email vote to donate \$5,000 to the Redwood Credit Union Community Fund for Sonoma County fire victims. Approved by all.
- **4. CheckMate Funding:** Lou is requesting the Board approve reimbursement for \$29.63 per month for the CheckMate software that helps locate missing members. It was agreed to retroactively pay this cost back to September 2019 and to continue for the next six months, at which time it will be reviewed for its effectiveness. It was moved by Kathy and seconded by Carol. Approved by all.
- **5. Membership Survey:** There was a discussion about how to move forward with the member survey. It was agreed to send surveys to all members through USPS rather than doing some by email. Phyris will send her information to Alix. Alix will oversee getting the steps done to complete this project. Bill and Patty will go to the Post Office to set up the account needed for return envelopes. The envelopes, return envelopes, and survey will be printed and sent to the membership. The returned surveys will go to Cora and Carol to collate, with Chris and Kathy helping.
- **6. Speakers for Membership Zoom Meeting:** Cora has scheduled Lisa Cannon, Director of the Food Bank, to speak at the November 17th Zoom Membership Meeting. - **10. Upcoming Retiree Representatives to SCERA:** The candidates for representation on the SCERA Board will be making brief presentations at the next Membership Meeting after the speaker.
