Minutes of the SCARE Business Meeting of May 24, 2011

- **1. Call to Order:** The meeting was called to order by President Carol Bauer at 1 p.m. There was a quorum, as there were more than 25 members present.
- 2. Guest Speaker James Bertero, Financial Advisor, Morgan Stanley Smith Barney: Jim spoke to the membership and answered questions about his job assisting clients in planning and arranging their financial affairs. Jim reported he looked over SCERA's investment portfolio and feels they are doing a good job investing "our" money.
- 3. Treasurer's Report: Carol gave the Treasurer's report in Phyris' absence. There was a discussion about not printing our Treasurer's report in our Minutes or on our website. We currently have a large amount of money in our bank account but this is expected to be used for legal fees in our suit against the County of Sonoma. Those present felt it is not necessary to post this amount on our website.
- **4. Legal Update:** Our attorneys filed the Opening Brief to the Federal Appellate Court on May 6th. It is very likely our case against the County of Sonoma will not be heard by the Appellate Court until next year.
- 5. Safety Net Program: Human Resources finally sent a survey to retirees concerning a possible Safety Net Program that was promised almost three years ago. Retirees who meet the eligibility criteria and face a financial hardship due to the increased cost of medical benefits may be able to seek financial assistance from the County, although there are still a lot of steps to be taken before it is available.

Some retirees said they are not comfortable filling out the survey even though it is confidential and does not require the retiree's name. Cindy Moore asked that an explanation of the Safety Net survey be put in the next Newsletter.

The next JLMBC Meeting is June 23, so a recommendation to the Board of Supervisors concerning a Safety Net Program is not expected soon.

- **6. CRCEA Conferences:** Alix Shor reported on the CRCEA Conference she, Phyris Tobler, and Dick Gearhart attended April 17-20, 2011, in San Diego. Sonoma and Mendocino Counties will be hosting the next conference at the Hyatt Regency Vineyard Creek Hotel in Santa Rosa October 24-26. Cindy Moore is chairing this event and is asking members to help plan and attend the event.
- **7. SCARE Luncheon:** Carol reminded members of the June 7th luncheon at the Quail Inn. Reservations (\$16 for members/\$20 for guests) must be sent to Patty Hamley by June 1.
- **8. Drawing for Door Prizes:** 41 members signed the roster for today's meeting. Richard Kelly, Greg Jacobs, and Lonna Necker won the drawing. Congratulations!
- **9. Retirement Board Meeting:** Carl Jackson reminded retirees that the Retirement Board meets the third Thursday of each month at 8:30 a.m. at the SCERA Office, 433 Aviation Blvd., Suite 100, Santa Rosa. Retirees are invited to attend.
- **10. Deferred Compensation:** Carl thanked Bill Hart, retired Human Resources Director, for starting the deferred compensation program that County employees have enjoyed for many years.
- **Adjourn:** There being no further business, the meeting was adjourned at 2:45 p.m. by President Bauer.

CRCEA Conference in Santa Rosa

The Sonoma County Association of Retired Employees (SCARE) and the Association of Mendocino County Retired Employees (AMCRE) cordially invite you to attend the California Retired County Employees Association (CRCEA) Fall Conference on October 24 – 26 at the Hyatt Vineyard Creek Hotel in downtown Santa Rosa.

CRCEA is made up of county retirees from the twenty 1937 Act counties in California. CRCEA keeps our county associations informed on current legislation that may affect our retirement benefits and issues of interest to us all. Counties take turns hosting these conferences approximately every 10 years and this fall's conference is being hosted by Sonoma and Mendocino County retiree associations.

This Fall's program includes the impact of national health care policies, issues surrounding Social Security and Medicare, 1937 Act specifics as well as public pension issues in general, benefits and cautions around use of social media and networking and a summary of current legislation affecting retirees moving through the State legislature. A hospitality reception hosted by Steve Pettee of Pacific Group Agencies, Inc. follows both the Monday and Tuesday sessions.

The opening session starts at 1:00 PM on Monday, October 24. Tuesday's session begins at 8:00 AM. On Tuesday evening there will be a banquet dinner (optional) at a cost of \$55 per person. The evening will include entertainment and door prizes. Wednesday morning is the CRCEA business meeting.

All but \$10 of the registration fee has been waived for SCARE and AMCRE members. The \$10 helps to cover the cost of refreshments served during the breaks. Registration forms will be available at the August 30 General Membership Meeting and the September 13 luncheon. JLMBC Update by Kathy Wertz

Retiree Safety Net Survey - As you know the County sent out surveys to all retirees asking about their interest and needs for a Safety Net Program to assist them with health plan premiums. The County reported that 600 responses were received; however they have not compiled the responses in order to give a report to the Board of Supervisors. We did hear that many retirees reported low incomes which showed a need for this program. We will keep you informed and we will continue to press the County for progress in the development of this program by meeting with BOS members.

Retiree Waivers - Another issue still in progress is the retiree waiver of health insurance with the ability to return to it at a later date. We were told the issue would go before the Board of Supervisors in June. However the waiver was only mentioned in the Board report that it was "being explored." We are now being told it will come up again when the final OPEB report is presented to the BOS in November or December.

SEIU presented a report to JLMBC on the "Cost to the County for Pensionable \$600 Monthly Health Care Benefit." The report showed that the \$600 monthly cash allowance/\$500 health insurance per employee is \$3.9 million more expensive than the prior 85% of lowest cost plan benefit level. SEIU asked that the County, through the JLMBC process to begin discussions of alternative structures to the \$600 monthly cash benefit and \$500 flat health insurance. HR staff was not receptive, but the committee supported SEIU's request.

Open Enrollment Changes - Of the 205 retirees who changed health plans during Open Enrollment, 105 went to Kaiser, 51 to AARP, 21 to County Plan PPO, and 28 to the County Plan EPO. 183 of the changes were due to the elimination of PacifiCare/Secure Horizons.

He allowed us to put a summary on our website so that our members who are not able to attend our meetings can access the information. Protecting Yourself from Fraud and Scams

Sad to say that there are all kinds of fraud and scams out there, and even sadder to note that approximately 50% of the scams are aimed at seniors who make up only 15% of the population. That is a very sobering fact if you are a senior.

SCARE is planning on having a speaker at our November General Membership Meeting who will be discussing ways to protect yourself from scams. Meanwhile, there is quite a lot of information on the web on how to do this. I thought some links to this information might be helpful and recommend that you take a look at them when you have a chance. This information is a little scary as there are so many ways people are trying to scam seniors these days but it is better to be forewarned, and therefore more likely to avoid getting taken in.

The Redwood Credit Union (which many retirees use) has a lot of information on different online frauds and scams (https://www.redwoodcu.org/site/tools_member_fraudscams.html). Anyone can go to this site even if you are not a member of the Credit Union.

OnGuard Online is a government site that has lots of information on how to protect yourself from online problems with topics like Avoiding Scams, Computer Disposal, Identity Theft, Phishing, Online Investing, Spyware, and many more.
