President's Message by Carol Bauer

On the bright side of life, it has been a nice summer and with the County Fair in progress, more fun is on the way. I hope everyone is enjoying the bounty and diversity of whatever area you live in. Here in Sonoma County the weather has been nice and since we got some rain last winter things are a little greener than they have been for the last few years. Although the drought is not over and a few more years of good rain would be helpful, the break this year was nice.

Unfortunately, there has been no break in the ongoing negative rhetoric about retiree benefits. Both pensions and health care continue to be the whipping post for all financial problems. Getting pensions and health care costs for retirees "under control" is the continuing message. Retirees continue to be blamed for the condition of roads, lack of services and generally anything for which the Board of Supervisors wants to shirk their responsibility. Nothing has to do with the financial crisis and the fact that the pension fund took huge losses during the downturn or that the cost of medical care continues to rise, sometimes by double digits each year. Retirees are to blame for costs that are out of their control and for which no one seems to have a solution other than to blame retirees. With that in mind we must continue to educate ourselves and others on the issues and work to develop solutions that are beneficial for all.

LEGAL UPDATE — Every time I write this message I hope I can report that the lawsuit is over. However we have not yet come to a final proposed settlement with the County. There are still sticking points which we hope to be able to resolve soon. Once we get a final agreement with the County, we will bring it to the membership for discussion and a vote. Remember there will be a vote by the membership at the meeting so please keep checking your mail as we will be notifying you of the date, location and time of the meeting once it is finalized. We will send notices to all members by first class mail and will also contact members who have asked to get information by email by email. You will receive a summary of the settlement.

We have confirmed that both Supervisor District 5 runoff candidates, Noreen Evans and Lynda Hopkins, will be attending our August General Meeting. If you have a question for the candidates and wish to have it asked at the presentation, please send to Bob Bulwa (bob@bulwa.com). I think you all know how important the Sonoma County Supervisors are to retirees as they make decisions that affect our benefits. We hope you will attend this meeting whether you are in District 5 or not.

Minutes of the SCARE Business Meeting of May 24, 2016

- 1. Call to Order: The meeting was called to order by President Carol Bauer at 1 p.m. There was a quorum, as more than 25 members were present.
- 2. Guest Speaker: Bob Bulwa introduced Fernande Marie Bencze, Vice President/Reverse Mortgage Specialist of Alliance Reverse Mortgage. Fernande works out of the main Redwood Credit Union Office, 3033 Cleveland Avenue, Suite 150, Santa Rosa, CA 95403. Telephone: 877-969-7383. Cell: 707-799-5888. Fernande explained that reverse mortgages are for people 62 years of age or older who use their homes as their primary residence. Reverse mortgages extract some of the equity in a variety of ways, including a lump sum or line of credit. The difference is that instead of paying the bank, the bank pays you. Fernande answered many questions from the audience about reverse mortgages.
- 3. Legal Update: Carol announced that, although mediation is over, our attorney and the County's attorney are still working together on a final agreement. The Legal Committee is involved as well. Once the agreement has been finalized, it will be sent out to the membership for review. A special meeting will be held, probably at the Vets Building, for members to vote on the agreement. Until then there is a confidentiality clause. After SCARE members approve the settlement, our lawsuit will be amended to make it a class action suit covering all people who retired prior to a yet-to-be-determined date. Carol said she has no idea what will happen to those who opt out of the settlement agreement.
- 4. JLMBC: There is nothing to report because the last two JLMBC Meetings have been canceled. HR is very busy with annual enrollment.
- 5. Next SCARE Luncheon: Carol reminded members of the June 8th SCARE Luncheon at the Quail Inn in Oakmont. Reservations (\$18 for members/\$22 for non-members) must be sent to Patty Hamley by June 1st. Fliers were included in the May Newsletter and also placed on the table at today's meeting.
- 6. Drawing: 36 retirees signed today's roster. Steve Fabian and Paul Klonsky won the drawing for free luncheon tickets to the SCARE Luncheon at the Quail Inn on June 8 or a future luncheon.
- 7. Adjourn: There being no further business, the meeting was adjourned.

SCERA Update Report—John Pels—July 2016

SCERA received its Actuarial Valuation for the plan year ending December 31, 2015 at its May meeting and in addition to the valuation presentation by Paul Angelo and Andy Yeung, of Segal Consulting; Administrator Julie Wyne presented a summary of plan data trends. Mr. Angelo and Ms. Wyne also presented the Valuation and plan data trends to the Board of Supervisors in June. The plan experienced an increase in its unfunded actuarial accrued liability largely due to assumption changes adopted earlier this year. The plan's funded level on a market value basis is 84.7%. The Actuarial Valuation can be found on SCERA's website on the Financial Reports page at http://scretire.org/Financial/Actuarial-Reports/.

At its June Board meeting, the SCERA Board addressed the Deduction from Retiree Warrants policy and ratified a decision to bring the County in line with the policy requirement of a single deduction being reported on the SCERA pay stubs covering medical, dental, vision and life insurance premiums. The Board acknowledged the frustration of some retirees who use the SCERA pay stub (as previously broken out by specific premium being deducted) as proof of payment for reimbursement from other plans, but also noted that technically SCERA is not the paying agent. The County is actually the paying agent for the premium payments and should be the entity providing proof of payment. A representative from the County indicated that the County did send out letters to retirees with premium breakdowns, which could be used as proof of payment. SCERA's Administrator, the County and SCARE representatives agreed that further conversations about proof of payment would be beneficial, and the Board supported this approach, while also supporting the decision to continue with a single deduction report on the pay stubs.

In July, the Independent Citizens Committee on Pension Matters delivered their final report to the Board of Supervisors. SCERA was not a focus of the report, instead it focused on the County's pension reform efforts, potential additional reform efforts that could be undertaken by the County, and transparent reporting. The Committee recognized that SCERA was an independently governed system that had its own financial reporting rules it is required to follow, and that SCERA is in full compliance with those reporting rules. It was noted that there is a potential for confusion among the public surrounding SCERA's financial reports and the County's financial reports, as each entity is reporting data according to financial reporting rules applicable to that entity, for different reasons. The Committee suggested that the County undertake to report its pension obligations by including both the SCERA unfunded actuarial accrued liability and the Pension Obligation Bond debt service payments.

JLMBC Report by Phyris Tobler

Annual enrollment is over and many retirees who were on the County Health Plan (CHP) did not read the booklet that showed that there was a huge increase in the retiree cost for this plan. Many didn't realize it until they got their pension check at the end of May and it was significantly lower. HR got so many calls that they actually allowed retirees another chance to make a change in their plan as long as they did it prior to July IIth. This may have been the first time that was ever done. There are other options for health insurance although those of you under 65 who live outside the Kaiser, Sutter and Western Health service areas are limited to CHP.

The County is concerned about the rising costs for both medical care and prescriptions in CHP. Costs are rising partly because the younger employees are leaving CHP as they have less expensive alternatives. We will be looking at this carefully in JLMBC and looking for some ways to keep the lid on premium costs. However, about the only way to keep premiums from going up is to increase deductibles and co-pays, so the retiree will still pay. Prescription costs continue to be very high with many retirees still using brand name drugs that can be 35 times more expensive than generic alternative. You as a consumer don't see that because you just pay a slightly higher co-pay but the plan pays the full cost. Some of you may think that because Anthem manages the plan for the County, they set the rates. That is not true. The only thing that affects rates for CHP is actual usage by County retirees and employees so the higher the usage, the higher the premiums will be. We will keep you updated.
