President's Report by Kathy Young

The Sonoma County Employees' Retirement Association (SCERA) Retirement Board met on July 20 to discuss the Negative Contingency Reserve (NCR). This negative reserve has grown to \$598 million. As long as SCERA maintains this fund, there will be no COLAs. The SCERA Board is reevaluating the Negative Contingency Reserve and will be looking at whether to keep or abolish it or set it to zero and then keep it. This will be discussed at their August 24 meeting. This discussion has great bearing on our chances of ever getting a COLA so you may want to attend the meeting on Zoom. It is important that SCERA Board members see that retirees are paying attention to this. More on pages 4 and 5.

Thanks to all who responded to our COLA survey. We received over 500 responses. Our COLA Committee continues to meet to strategize next steps.

Please join me in thanking Bill Robotka for his 7 1/2 years of service to the SCARE Board. Bill has decided to step down from the Board although he will continue to work with the SCCLO Committee, North Bay Labor Council and Independent Citizens Pension Committee. He will be missed on the JLMBC Committee where he has been a vocal questioner of why health insurance rates have such high increases – especially those for the County Health Plan. Fortunately, Phyris remains on that committee and has also been instrumental in getting the County to decrease rates. Bill, thank you for all you have done for the retirees of Sonoma County.

August 22nd Membership Meeting Speaker from The American Red Cross

The American Red Cross was established in Upper New York State in 1881 as a non-profit humanitarian aid organization. Since then, the ARC has expanded its network of services to include all 50 states, and is affiliated with The Red Cross Red Crescent which serves 192 countries around the world responding to a multitude of issues including natural disasters, health epidemics, and refugee and migrant crises.

The north bay chapter of the American Red Cross serves Solano, Marin, Napa, and Sonoma counties. It's Sonoma County headquarters is located at 5297 Aero Drive, Santa Rosa, CA, telephone 707-577-7600.

At our membership meeting on August 22, 2023, at 1:00 pm, at the Finley Center, Santa Rosa, CA, and accessible via ZOOM, Vincent Valenzuela, Executive Director of the North Bay Chapter of the Red Cross will be our guest speaker. He will provide an overview of the organization, covering a variety of topics including:

- + Disaster preparedness; emergency assistance (shelter, food, medical care, financial assistance) in response to a long list of qualifying disasters including fires, storms, and earthquakes; long-term recovery services and programs for individuals and communities.
- + Educational training and classes online and in person for individuals and organizations covering a variety of health and wellness issues, including adult, child, and baby first aid, CPR and AED, water safety for parents and caregivers, first aid for severe trauma, cat and dog first aid and more.
- + Blood donations and the positive impact donations have on the medical care system, trauma victims and patients with chronic diseases.
- + Services available for active-duty military, veterans, and family members.
- Volunteer and donation opportunities. Nationwide, 95% of disaster relief workers are volunteers. Learn about local volunteer options and, if able to provide a financial donation, how donation dollars are distributed to the community.

Speaker Valenzuela has over 20 years of non-profit experience and strongly believes in the importance of listening to and building connections and partnerships between non-profits, diverse communities, people in need and volunteers to successfully carry out the missions of humanitarian organizations. Vincent began his journey with the Red Cross in 2018. He has learned invaluable lessons from being deployed to multiple local and national disasters, and will share some of his stories/insights during his presentation at the upcoming membership meeting. As a North Bay resident, Vincent reports that "in his spare time, he enjoys adding to his collection of vinyl record collection, cheering for Bay Area sports teams, and spending time with family and friends."

JLMBC Report by Phyris Tobler

HRA Update: If you are a member of the SCARE lawsuit class (retired by 6/30/16), there was a deposit of \$32.90 into your HRA with P&A on July 1, 2023.

Shingles Vaccinations: Shingrix is considered a preventative vaccination by the CDC for people 50 and older so there should be no copay. One of our members was trying to get the vaccine and was being charged a hefty copay, whether going through doctor or pharmacy so I checked with Human Resources Benefits Manager to get information on how our different plans treat this vaccine.

County Health Plan pays for the shingles vaccine through the doctor based on preventive guidelines, per the CDC "CDC recommends two doses of recombinant zoster vaccine (RZV, Shingrix) to prevent shingles and related complications in adults 50 years and older. Shingrix is also recommended for adults 19 years and older who have weakened immune systems because of disease or therapy.

Kaiser: Shingrix is included in their drug formulary. It is not limited to Medicare participants. Shingles vaccines are generally provided by appointment as an injection. It is coded as preventative and should be \$0 cost share to the member.

Sutter Health Plus: Covers the two-dose shingles vaccine in the category of Immunizations for ages 50 and above under the Preventive Care benefits at no cost share to the member for all plans.

Western Health Advantage: The Shingrix vaccine is recommended for members 50 years and older, it is covered as a preventative medical benefit and a Prior Authorization is required. The vaccine is not covered as a pharmacy benefit and must be obtained in the physician's office.

I am not able to ask AARP what they do but given that the CDC now says it is a preventative vaccination, I don't think they would be charging a co-pay. If a doctor or pharmacy tries to charge a co-pay, I would challenge it.

Health Insurance Rates: Both retiree and employees reps at JLMBC try to keep the insurance rates down. Kaiser, Sutter and Western Health Advantage (WHA) all make presentations to JLMBC showing what the past year has been like in terms of usage. A reminder that with the exception of the Medicare plans, rates are based just on Sonoma County usage so when our usage is high, rates go up. The HR Benefits Manager and our Consultant negotiate with the various insurance companies to try to get the lowest rates possible.

We have given Kaiser a hard time because their rates are higher than Sutter and WHA. For many years, Kaiser and the County Health Plan were the only under 65 health plans, with Kaiser being much less expensive so most actives and retirees enrolled in it. However, with the addition of Sutter and WHA, Kaiser became more expensive than either and it started losing members. Kaiser Medicare rates have been gradually decreasing and it is now similar in cost to AARP/UHC with a better prescription plan.

County increases for the 2023-24 year which began in June: Kaiser—1.6% increase with 4.6% decrease for Medicare; Sutter —5.5% increase; WHA—4.3% increase with 3% increase for Medicare. All pretty moderate.

In comparison —The CalPERS (which has a huge membership) health insurance increases effective January, 2024, were just published. They are skyrocketing with Kaiser going up 13% and WHA 6%. Kaiser Senior Advantage is increasing by 14.67% although WHA is decreasing by over 18%. Cal-PERS has many other plans but their average increase for under 65 will be about 11% and 9.5% for Medicare. This both makes our increase this year very moderate but it also may portend a larger increase next year.

SCARE COLA Committee by Ed Clites

The committee would like to thank the nearly 500 members who responded to our recent COLA Survey. If you have not yet responded and would like to be heard, please go to our online survey (https://bit.ly/SCARE_COLA) to be added to the results. The goal of the survey was to capture about a dozen of the most compelling responses to share with the Board of Supervisors (BOS) and others in our quest to obtain an ongoing COLA. As it stands now even an Ad-Hoc COLA isn't feasible due to negative returns in the retirement fund. A number recently shared with the SCERA Board to get in the positive was in the neighborhood of \$1.2 billion, yes billion, dollars.

Unfortunately, there were no "smoking gun" responses that the committee felt would compel the BOS to seriously consider funding an ongoing COLA. Some, but not an overwhelming number, of retirees have moved out of state. Many cited the combination of Social Security and Medicare assisting them in getting by. Almost everyone cited increased costs across the board and some even cited the talking points that we included in the Spring newsletter. Those who are not yet receiving Social Security and Medicare are all in the enhanced retirement category. At this point we are in a holding pattern. At last Thursday's SCERA Board meeting, CEO Julie Wyne noted that, although all bargaining has wrapped up, she has not yet contacted the CAO to schedule their committee meetings. She noted that the Negative Contingency Reserve, which is very high, is keeping SCERA from considering any action on COLAs. The SCERA Retirement Board will be considering possible changes to the current requirements for the Negative Contingency Reserve at their August 24th Board Meeting. I encourage you to attend that meeting by Zoom. President's Report on page 1 has information on how to do this.

Safe Mobility or Fall Prevention Classes by Sonoma County Area Agency on Aging

Safe mobility is critical to healthy aging. More than 3 million older adults are seen in emergency rooms annually with over 300,000 of them hospitalized for hip fractures. Falls are the leading cause of injury-related death among older adults.

With a little effort, many of these falls can be prevented. Assessing and addressing risk factors such as balance and fitness, health conditions and medications, foot health and shoes, and safety factors in the home can reduce falls and help older adults maintain independent lives in their communities.

There are many organizations throughout the county engaging in fall prevention efforts. These activities include exercise and balance classes, walking groups, self-assessment tools, professional fall-risk evaluations, and support groups focused on reducing the fear of falling that can limit one's quality-of-life.

The Sonoma County Adult and Aging Division is committed to promoting activities that reduce falls and support healthful aging and independence. In addition to convening groups of providers to coordinate and expand fall prevention efforts, the County offers periodic trainings and sponsors delivery of the evidence-based 'A Matter of Balance' (MOB) course conducted in community-based settings throughout the county. The 8-session MOB course provides participants with the knowledge and skills (including exercises) to increase one's confidence and safe mobility. Classes are now available in Spanish and English. SCERA Report by John Pels

OPERATIONS: At its July 20, 2023 Retirement Board meeting the SCERA Board heard a presentation from staff and the Plan's actuary on the Negative Contingency Reserve. This is a reserve that was created by Board action in November of 2002 to track shortfalls in interest crediting when the Plan does not earn enough investment earnings to fully credit interest to the reserves that account for Member and Employer contributions, amounts set aside for benefit payments and amounts set aside for COLAs that have already been granted. This presentation explained the Negative Contingency Reserve and why it was created, how it reached its current negative balance, how it impacts funding for the Ad Hoc COLA, and what it would take to get it back to a positive number. At the August 24, 2023 meeting, the Board will again hear from staff and the Plan's actuary on policy considerations for changing SCERA's approach to interest crediting and the Negative Contingency Reserve. This is a precursor to meeting with County representatives regarding the Ad Hoc COLA program.

Staff secured an audit of the Plan's actuary and the results will be presented at the August 24, 2023 meeting. It is best practice to do so every five or so years and the actuarial audit firm replicates the last actuarial valuation to see if their results are a match to the Plan actuary. It is also an opportunity to talk about best actuarial practices.

Personnel changes are underway with the recruitment of a new Office Assistant to replace the recently promoted Office Assistant to a Retirement Benefits Specialist. This is the second time SCERA has promoted an Office Assistant to a Member Services position which is in line with its Strategic Plan goal of promoting a culture that embodies respect both inside and outside of the organization. SCERA will be filling an Accountant III position to shadow the current Accountant III who has announced plans for retirement within the year.

INVESTMENTS: Investment returns through July of 2023 are in line with the plan's investment earnings assumption of 6.75%. Staff is planning the agenda for its Planning Session on October 11 and 12, 2023. In addition to the Business Plan presentation staff is planning to hear from an expert in China and an economist. Investment Manager panels will round out the sessions. The results of the Asset Liability Modeling Study will be presented to the Investment Committee in the fall and the Board will determine whether changes to it asset allocation are necessary. Asset allocation is a factor that the Plan actuary uses when evaluating the investment return assumption during the experience study, which is scheduled for next year.

Do It Yourself (DIY) Energy and Water Savings Toolkits are available for checkout at all branches of the Sonoma County Library.

The Toolkits include the tools and information necessary for customers to perform their own home upgrade projects to weather strip windows and doors, monitor electrical usage, find water leaks and make their homes more efficient with LED lightbulbs. There are several things that you can keep — low flow aerators for bathroom and kitchen faucets; low flow showerheads (2); LED lightbulbs, and more. Sonoma County Library cardholders can check out the kits for up to three (3) weeks.

Emily Rogan provided a very informative program at our Membership Meeting on May 23rd. United Policyholders (www.uphelp.org) is a non-profit organization that focuses on planning for and recovering from disasters, and advocacy for consumers to strengthen laws that protect policyholders and provide disaster survivors more flexibility. It provides assistance in purchasing insurance, knowing how much you need (number one problem after a disaster is that people don't have enough insurance to rebuild). They provide information and services before and after disasters including where to look if your insurance company drops your coverage and they offer many Zoom sessions on navigating insurance claims. She also talks about "hardening" your home to make it more fire resistant. This sometimes can give you a discount on insurance.

We know all of our members have experienced the increase in home insurance costs and many may now be in what is considered a 'fire zone', meaning cost has doubled, tripled or you have been dropped. We realize that most of our members are not able to attend our Membership Meetings and think it is important to share the information Emily provided on ways to deal with the above. United Policyholders provides services to the entire country. Since there seems to be no lack of disasters, this is good information to have available.

However, since her presentation, it was announced on the news that State Farm will no longer be writing any new homeowner policies in California although they are not dropping anyone. This is not a good sign.

I recently was planning on taking some hazardous waste to the dump and decided to check to see what else could be included in hazardous waste. I went to the https://zerowastesonoma.gov/?locale=en website and found a list of what they considered hazardous waste (https://zerowastesonoma.gov/recycle-dispose/residents/commonhousehold-hazardous-waste-hhw?locale=en)

I was shocked to see some of the items on the list. They were not things that I ever thought were considered hazardous. For years, I've been putting things in recycle or trash that are on this list. I thought many of our members might be surprised too so they are listed here.

It was not clear from the website whether you could wash out containers for cleaners, for instance, so I contacted zerowastesonoma and asked if empty bottles that were washed out were recyclable. This is the

answer I received. "Empty and tripled rinsed plastic bottles/containers that have held household cleaners, disinfectants and pesticides are accepted as recycling in the blue recycling bin. Make sure to leave the caps on."

The biggest surprise was that toiletries were on the list but evidently some have hazardous components and they can't identify which ones do so they say all.

I think most, if not all, of us are trying to do things that are good for the planet and reduce waste, so you may want to check out zerowastesonoma.com website because it has a variety of ideas for accomplishing this.

The website also has a calendar that shows when hazardous waste collection will be in your community. Hazardous waste collection is available at the main dump on Meacham Road in Petaluma. Check website for days when they accept hazardous waste.



The "Insurance" webpage has links to the Sonoma County Human Resources page that shows the health insurance coverage available to retirees. This includes the Annual Enrollment Booklet; just in case you tossed yours and now would like to check something.
