### President's Report by Kathy Young

Fall has arrived. I hope everyone is enjoying the Fall colors.

Julie Wyne, CEO of the Sonoma County Employees Retirement Association (SCERA) will give us an update on the health of the pension fund and recent policy changes. SCERA has changed their policies to make it easier for the Board of Supervisors (BOS) to move forward with COLAs. At the October 22 BOS meeting, SCERA presented their annual State of the Retirement System Report. Julie was asked what options there may be for COLAs. Julie presented several ways a COLA could be accomplished if the BOS wanted to do so but they would need legislation to do anything besides give an 80% purchasing power COLA to everyone. We need to keep reminding the BOS to address COLAs, and not push the issue down the road.

Many of you have asked to do more in helping secure a COLA. Some of you have great stories to tell about the impact of not getting a COLA. We are asking more members to join our effort in giving the County accurate and timely information on the real impact this has on the lives of most retirees. If you are willing to be involved in this effort, please send an email to me at kyoung2@sonic.net and indicate whether you would be willing to write letters and/or go to Board of Supervisor meetings.

We will be voting for Board members at the next Membership Meeting. Terms will be up for Carol Bauer, Shaun Du Fosse, Ed Clites, and me. These members are willing to continue. We are losing 2 of our long time Board members—Patty Hamley and Cora Guy. This leaves two vacancies on the Board. We have a wonderful group of people on our Board. We have lively discussions, and you will gain a lot of knowledge on many topics. We really need 2 new members. You should seriously consider becoming a Board member. Contact me, or any Board member, if you have questions or are interested in joining us.

Members who are covered by the SCARE lawsuit settlement have inquired when the County contribution for health insurance will decrease. See page 4 for details on this change which will not happen until 2026.

### **November 26th Membership Meeting**

Julie Wyne, CEO of SCERA, will join us. She will update us on the overall health of our pension system as well as on what is happening with the possible granting of COLAs. Please plan to attend either in person or on Zoom — https://us06web.zoom.us/i/8954632781?omn=83997314337

Just to fill you in a little in advance. SCERA approved several changes that will make it less costly to grant a COLA. This is very important as the Board of Supervisors will have to fund it. The cost to give a COLA as of March 2024 with changes that were made was \$330 million. It will not be reconsidered this year and by next year, the cost will be more.

SCARE Board members will be meeting with Board of Supervisor members to make them aware of how badly a COLA is needed.

If you are talking to people about our lack of a COLA or writing the Board of Supervisors, here are some talking points:

- ♦ Sonoma County's Ad Hoc COLA is not working. Sonoma County retirees have not gotten a cost of living increase since 2008, and those who retired after 2003, have never gotten a COLA. Almost all public agencies in California have automatic COLAs which means they get a 2 or 3% COLA every year.
- ◆ Half of retirees get pensions under \$2,500/month, and many get much less than that.
- ◆ Per the retirement office, people who retired before 4/1999 would need a 54% COLA in order to reach the 80% purchasing power COLA that is currently in SCERA policy. There are around 800 retirees in this group.
- After telling employees that the County would cover most of the cost of health insurance during retirement, they cut their contribution significantly in 2009.

SEIU and the North Bay Labor Council have both agreed to support us in our bid to get COLAs for current retirees.

Don't toss out last night's leftovers. Refrigerating cooked rice, pasta, and potatoes rearranges the starch molecules, forming a type of fiber called <u>resistant starch</u>. It's broken down in the large intestine, which creates short-chain fatty acids that feed healthy bacteria in the gut. And blood sugar levels may rise more slowly after meals with resistant starch. According to a <u>2015 study</u> in the Asia Pacific Journal of Clinical Nutrition, cooked white rice that had cooled for a day had 2.5 times the amount of resistant starch as freshly cooked rice—and led to a smaller blood sugar response. The amount of resistant starch didn't change much when the cold rice was reheated. While more research on resistant starch is needed, studies suggest that it may help protect against diabetes, weight gain, and certain cancers.

#### **Health Insurance Information**

**Cost of prescriptions capped**: Good news for those on Medicare — As of January 1, 2025, out of pocket cost for prescriptions cannot exceed \$2,000 for the year. This change is most likely to affect those with the AARP/UnitedHealthcare plans as some prescriptions under that plan can be very costly.

**New Anthem Medicare Advantage Plan**: The County of Sonoma offers the Anthem Medicare Preferred (PPO) with Senior RX Plus plan, which includes medical and prescription drug coverage, as well as additional benefits and programs. As a PPO, you can visit any doctor or hospital that accepts Medicare, both in-network and out-of-network, at the same cost share.

For certain services, your in-network provider will need to obtain prior authorization from Anthem. If you see an in-network doctor, they will handle the prior authorization for you. If your provider accepts Medicare but is not in Anthem's network, ask your doctor to get prior authorization for any major procedures.

If you are taking a brand-name drug and have previously tried a generic drug that was ineffective, your provider can submit a prior authorization request with the medical reason why the generic drug will not work for you.

Be your own advocate or ask for assistance by calling Anthem Members Services at (833) 848-8730, Monday through Friday, 5 a.m. to 6 p.m. PST for answers or plan details. You can also receive support through CareCounsel (888 227-3334), which works directly with your doctor and insurance company. This service is available to all Sonoma County retirees and employees, with retirees being the primary users.

**Kaiser** has Patient Advocates that can help you get service you need if you are being told no.

If nothing else works, you can appeal the denial of a claim or prior authorization. According to the Kaiser Family Foundation, in 2022 more than 80% of those who filed an appeal after their request for prior authorization was denied by Medicare Advantage were successful.

#### County Contribution for Health Insurance to Decrease in 2026 under Settlement Agreement

Note: This only applies to those in the SCARE Settlement with the County, which means you must have retired prior to July 1, 2016.

One of our members asked me to put this reminder in the newsletter. For those of you affected by the settlement, the County contribution to your health insurance will decrease from 'up to \$500' as it is now to \$200/month as of June 1, 2026, and it will continue at that rate until 2041. It is likely that most people affected by this will be on Medicare but the \$200 will not cover cost for any of the Medicare plans for a single retiree, much less if you are covering a spouse.

Those who retired on or after July 1, 2016 are covered by whatever MOU was in effect at the time they retired. So far, they get 'up to \$500' with no end date.

The only way that the settlement can be changed is if both parties (SCARE and the County) agree to the change. We will be talking to the Board of Supervisors to see if they are open to modifying the settlement agreement.

#### **Preventing Identity Theft**

One of the best proactive things you can do to protect yourself against financial fraud is to freeze your accounts at the credit reporting agencies of Experian, Equifax and TransUnion. It is also one of the easiest things you can do. If you do this, it locks up your account and no one can open a bank account or take out a loan/credit card or rent an apartment in your name even if they have access to your personal data. It is easy to do and can quickly be unfrozen if you want to take out a loan or get a new credit card. Once that is approved, you can immediately refreeze it again. There is no charge for this. You have to contact each credit bureau separately. You can get their contact info on the internet.

Many retirees have older parents who may be contacted by scammers and who might give out sensitive information like SSN or bank account info. You may want to suggest that they freeze their credit bureau accounts.

#### Presentations from the August 27th Membership Meeting Available Online

At our August 27, 2024 Membership Meeting, we had presentations by Emergency Prep Help and the Sonoma County Library. Both presentations were very informative. The library information is useful for all people in Sonoma County. The library has added a lot of services which were covered in their presentation.

Emergency Prep Help provides workshops for seniors to help them prepare themselves for natural disasters and other emergency situations. Their stats show that it is primarily seniors who die in disasters. They give out go-bags at their workshops and show you how to personalize them. Workshops are free and you can sign up for workshops at www,emergencyprephelp.org under the Events link. One of our members who had attended their workshop said it was 'fabulous' and encouraged other retirees to go.

#### **Council on Aging Awarded Fall Prevention Grant**

Council on Aging has been awarded one of nine prestigious Innovations in Fall Prevention grants from the National Council on Aging. This grant aims to address the needs of seniors who are at risk of falling and are homebound, ensuring they receive the necessary support to improve their safety and mobility.

The program spans eight weeks and involves an inhome Coach who will meet with participants twice weekly. These sessions will focus on customized exercise routines and flexibility/mobility programs tailored to each senior's needs. The Coach will guide participants through the exercises, ensuring they are performed correctly and effectively.

To assess the program's success, participants will undergo pre-and post-testing, providing valuable data on their progress. Additionally, each participant will receive exercise equipment and an Emergency to -go bag to enhance their safety and preparedness.

Throughout the eight weeks, seniors will have ample opportunities for learning, education, and movement, contributing to their overall well-being. This initiative not only aims to prevent falls but also to improve the quality of life for homebound seniors.
