## President's Message by Kathy Young

It has been a very busy few years for the SCARE Board. We conducted two member surveys, one to find out what was most important to you (Cost-of-Living Adjustment [COLA]) and second to gauge the impact of not having COLA since 2008. We then focused on COLA/insurance contribution. We supported Sonoma County Employees Retirement Association (SCERA) in changing their policies to make it easier to implement COLAs once the Board of Supervisors (BOS) decided to do so. SCARE Board members met with each Supervisor and the County Administrator (CAO), we have attended many BOS meetings to make presentations and reinforce the need for COLA/insurance contribution. We have written many letters to Human Resources, CAO, and BOS regarding the impact of not having a COLA including asking them to inform prospective hires that there has not been a COLA given in 18 years. We heard from many members that if given that choice, they would have gone to another county to work. Legislative changes are needed to move forward with some kind of COLA since the BOS is unwilling to bring all retirees up to 80% of their purchasing power, which is in the current legislation. Recently Chris Rogers introduced Legislative bill AB 1601, and it will hopefully make it to the legislative queue for action this year.

We continue to advocate for Sonoma County retirees; we are starting a Political Action Committee (PAC) to have more local political influence. We continue to press the BOS to address county retiree issues. We are updating our website and improving our social media presence. Our newsletter is always full of very useful information.

I have had the privilege of working with this dedicated group of volunteers as the President of SCARE for the past three years and will remain on the board as Secretary/Immediate Past President. Please join me in welcoming **Andre Bercut** as our incoming President. This board will continue to work hard, putting in many hours, to support Sonoma County retirees. My heartfelt thanks go out to this dedicated group.

At our next SCARE Membership Meeting, Bo Carr from AMBA will be our speaker. See page 2 for more details. We will also be discussing and voting on the PAC. Language to be voted on is shown on page 2.

## February 24th Membership Meeting Speaker

As most of you know, SCARE offers its members discounted group insurance through Pacific Group Agencies. AMBA has acquired Pacific Group Agencies but will continue to provide insurance under name of PGA or PGA/AMBA. The reason they are able to provide cheaper insurance to a small group like SCARE is that included in the group are large counties like Los Angeles, San Diego, and Sacramento.

AMBA is a Texas based company. However, we will still be dealing with the same people who have their office in Santa Clarita, CA. The local support network is still Steve Pettee, Vivienne Reyes, Katie Valdez and Jacky Casillas. **Bo Carr** will be making a Zoom presentation at our February 24 membership meeting about their services. They offer more than PGA did including access to discounts for restaurants, travel, and wellness centers. Our members will get a Benefits Guide from them at about the same time as they get the Benefits Guide from the County. This will allow you to compare dental plans and decide whether you want the County plan or the one through PGA/AMBA. See more on dental plans on page 3.

### **Need for a Political Action Committee**

Also at the membership meeting will be a presentation on why we are asking the membership to approve a Political Action Committee.

The Board of Directors has been engaged for some time now in discussions concerning our lack of a cost-of-living adjustment (COLA) and the decrease in settlement money being provided for health care. The SCARE Board has met with individual supervisors and spoken at board meetings in pursuit of these goals and while there is a general feeling that the county may be interested in looking at some type of COLA, there is no guarantee that it will ever happen without further work from us as retirees.

With that in mind, a significant amount of time has been spent on whether to form a political action committee/political issues committee (PAC/PIC) and use that as a vehicle to effect positive changes to the Board of Supervisors.

The SCARE board has decided that it is in the best interests of retirees that we form a political action committee and fund it so that we may take further actions to achieve a cost-of-living adjustment. We all know that it will take political pressure to gain what we are after. If the Board of Supervisors wanted to do the right thing, it would already have done so.

The committee shall be funded using dues money as that allows us to avoid paying taxes. The focus of the committee shall be the Board of Supervisors and any legislation that may impact us as retirees. The Committee shall **NOT** be involved in federal elections. You will be asked at the February member meeting to vote on the proposed bylaws so that the Board may continue to advocate fully on behalf of us all. Proposed change:

Article VIII, Section 2,

h) The Political Action Committee – whose duties shall include the gathering of information on upcoming elections, recommendations to the Board of Director on endorsements and expenditure of PAC/PIC-related funds. Approval of all PAC/PIC disbursement requests shall be determined by a vote of the Board of Directors. PAC/ PIC will be funded by dues.

## JLMBC Report by Phyris Tobler

### Health Insurance Information

Annual enrollment will be from March 23—April 10. Be sure that Human Resources Benefits Unit has your current address so you receive the Retiree Benefits Guide.

Update on expected changes to health insurance rates that will be effective June 1, 2026

- For those on the County Health Plan who are under 65, there will be no change in the premium. Increase is being covered out of the CHP reserves.
- Kaiser rates for under 65 for the HMO will go from \$1,220 to \$1,281, or 5%. Kaiser's Medicare rates will go from \$356 to \$382 for a 7.3% increase.
- Sutter cost for HMO will go from \$856 to \$1,010 for an 18% increase. They originally gave county an increase of 24% but came down a little. Sutter doesn't have a Medicare plan and they do not currently plan to have one.
- Western Health Advantage is going from \$842 to \$894 for a 6.2% increase. They no longer offer a Medicare plan.
- Unfortunately we do not yet have rate for Anthem. Current rate is \$286 but it is likely to go up 5%. I think it will still be the least expensive Medicare plan.
- AARP/UHC plan is an individual plan so rates vary depending on geographic area and age. Since their rates usually increase the first of the year, if you have one of these plans, you should have a pretty good idea of what your rate will be. Their rates have increased over the last few years so it is likely that it is no longer the least expensive plan. It can also be very expensive if you are taking any brand name drugs.

The County dental insurance (the PPO through Delta Dental) is increasing from \$47.06 to \$48.47. The only thing that is going down, but not by much, is the life insurance. It is currently \$9.85 and it will be \$9.50.

Other information on Anthem Insurance:

Providence sent out letters to people who had Providence doctors saying that they wouldn't be accepting Anthem patients anymore. After talking to HR, that was done in error. Anthem has contract with Providence until 2028.

More recently, Anthem had a cyber attack and people with that coverage have received letters from Conduit letting them know and explaining they have protection through Privacy Solutions. This is legit and Human Resources will be sending letter to all affected retirees explaining what they should do.

Other information:

If you are taking a GLP1 drug like Wegovy, some insurance is no longer covering it depending on what your health situation is. Generally, it is not being covered if it is just for weight loss. It is unclear how Medicare is handling this.

SCARE will again be offering a variety of different types of insurance through Pacific Group Agencies/AMBA. We expect it to be an expanded offering this year. Members should be receiving a booklet from them about the same time as the County Benefits Guide comes out. **Be sure SCARE has your correct mailing address.** You must sign up for the dental and vision insurance during open enrollment whereas you can take out any of the others at any time. As the county dental insurance gets more expensive, it is worth comparing the PGA offering with the county dental plan. The PGA one is a little richer and allows payment to non-network dentist, although the coverage is not quite as good. Once you have both booklets, you should compare the coverage before making a decision. PGA insurance uses the Ameritas network instead of Delta.

Vision insurance is still offered through SCERA and you should get a flyer that shows the coverage.

## **Effort to Get BOS to Reopen SCARE Settlement and Increase Contribution to Health Insurance**

One of our Board members got a letter from Chris Coursey related to reopening our settlement agreement. It was a definite no as he states the cost would be \$10 million a year in a county budget that is already showing a budget deficit. He said he was giving us this info so we had the background on why the Board didn't want to reopen settlement, but he also said that he wasn't telling us not to ask. So, if this affects you, keep writing to the Board of Supervisors.

It may be that the BOS thinks that because they approved legislation that would allow more flexibility in giving COLAs, that that is enough. Of course, legislation has to be approved which we hope will happen this year but there is no guarantee. And even if approved, there will be no COLA in 2026.

### Preventing Falls

25% of older adults fall at least once a year. In 2023, more than 41,000 people over age 65 died from one. Clearly this is a serious problem. Maintaining your strength and balance are key.

Suggestions to prevent falls from Consumer Reports "On Health" are: (1) walking. 150 minutes/week can cut risk of falling by 30%. (2) tai chi increases strength and balance (3) wear good shoes like sneakers, even in the house (4) check meds as some contribute to dizziness. See if there is an alternative. (5) check your lower body strength by doing sitting to standing exercise. Many places suggest weight training in addition to physical exercise. If you are shaky, there are a lot of online suggestions for building strength and balance.

You may be able to pay less for prescription drugs by skipping insurance and paying cash. Using discounts available from websites like [America's Pharmacy](#), [Blink Health](#), [GoodRX](#), [Optum Perks](#), [SingleCare](#), [RXSaver](#) (by RetailMeNot), and [WellRX](#) may make your costs lower than your insurance copays. But be sure to compare costs.

### **General Membership Meeting February 24, 2025**
