President's Report by Kathy Young

Cost of living increases remain foremost in our board activities. Julie Wyne, CEO of SCERA, will be the speaker at our November 28th Membership Meeting. She will give us a status report on both the Negative Contingency Reserve and the Interest Fluctuation Reserve. She will explain how these two reserves affect COLAs and what options are being considered that might possibly allow for a COLA. We hope you will join us at this meeting. SCERA is having its election for the retiree representatives. There are 2 positions, one is the trustee and the other is the alternate. Neil Baker is running unopposed for the alternate position so you will not get a ballot for him. John Pels and Mark Walsh are running for the trustee position. He is currently a SCARE board member, has represented retirees on the SCERA board for many years in the past and will continue to support our concerns in the future.

Good news is that the Social Security Cost of Living Adjustment is 3.2%. That will be decreased a little as the Medicare Part B is going up \$9.80/month for a total of \$174.70/month. This is more if your income is over \$103,000/year.

Julie Wyne, CEO for SCERA (our retirement association), will be the speaker at our November 28th Membership Meeting. She will be giving us an update on what is happening with the **COLA policy decisions** related to the Negative Contingency Reserve and the Interest Fluctuation Reserve. Current policy on these two reserves and a lack of excess earnings makes it almost impossible for SCERA to recommend a COLA to the Board of Supervisors.

Julie will be explaining how these two reserves affect COLAs and what options are being considered that might possibly allow for a COLA.

The SCERA Retirement Board will be discussing, and possibly making policy recommendations, on these reserves at their December 14th board meeting. It is crucial we show how important this issue is to retirees. We can do this by attending the December meeting on Zoom. The Zoom link will be available on the meeting agenda on the SCERA website (https://scretire.org/administration/meeting-calendar/retirement -board) plus we will send it to you by email the week of the meeting if we have your email address.

SCERA has a COLA subcommittee that will be meeting with County staff in November. The bottom line is that no matter what the Retirement Board recommends, the Board of Supervisors must approve any changes so this is not likely to be settled quickly.

JLMBC Report by Phyris Tobler

Health Insurance Rates: We are in the process of looking at proposals for County health insurance. While no decisions have been made, there probably won't be major changes other than rates will continue to increase.

Sutter members can get vaccinations at CVS. A shorter wait.

Delta Dental coverage for extra annual cleanings: If you are enrolled in Delta Dental PPO, you are eligible for additional annual dental cleaning if you have any of the following conditions: ALS, cancer, chronic kidney disease, diabetes, heart disease, HIV/AIDS, Huntington's disease, joint replacement, lupus, opioid misuse and addiction, Parkinson's disease, rheumatoid arthritis, or Sjogren's syndrome.

Home Improvement Tax Credits

The Inflation Reduction Act extended and expanded tax credits for energy-efficient home improvements starting in 2023. You can get an Energy Efficient Home Improvement credit for 30% of improvements, including home energy audits, Energy Star-qualified doors and windows and HVAC upgrades. Credit is worth \$1,200/year.

The Residential Energy Efficient Property Credit has been extended through 2034. It's worth 30% of the cost of installing energy systems such as geothermal heat pumps, solar energy systems, or battery storage technology.

Sonoma County Employees Retirement Association (SCERA) Elections

The SCERA election for the retiree representatives for the 2024-2026 term will be in November. This is a very important election. All retirees will get a ballot in the mail. They are mailed on Nov. 15th and must be returned by Dec. 5th. We have very good candidates this year but the SCARE Board is supporting John Pels. He is currently a SCARE board member and has served in that capacity for many years. He has also represented retirees on the SCERA board for many years in the past and will continue to support our concerns in the future.

John Pels — I am seeking your vote for the Retiree representative (8th Board Member position) on the Sonoma County Employees Retirement Board. While employed at the Sonoma County Sheriff's Office, Detention Division, I served as a Trustee for the Sonoma County Retirement System from 1997-2009. I was Chair of the Retirement Board and Chair of various committees. I moderated educational sessions designed for trustees and investment professionals for the State Association of California Retirement Systems. I am also a graduate of Grand Canyon University and have my Bachelor's Degree in Business Management.

I retired in January, 2010. After a short break, I returned to the Retirement Board as the retiree representative in 2013. I continued my education and devotion to my duties as a trustee. I serve as a fiduciary to the retirement system. I have a responsibility to manage the retirement system for the exclusive benefit for all of the systems' members and beneficiaries. I continued to serve as the retiree representative until 2020.

I joined the Sonoma County Association of Retired Employees (SCARE) in 2020 and have served as a Board Member for the last 3 years. I have continued my involvement with the Retirement System. I virtually attend Retirement Board meetings in effort to stay connected and informed with the performance of the system, policy changes and ongoing COLA discussions. I am dedicated to protect our retirement benefits and maximize those benefits going forward. I am asking for your trust and vote to return as your retiree representative.

Mark Walsh — Please select me to represent your interests on the retirement board. The board of trustees makes important decisions that impact the measurement and delivery of retirement benefits. You deserve a representative that is willing and able to engage others in complex government finance conversations that impact the measurement of benefits.

I have experience serving on the board of trustees for the Sonoma County Employees Retirement Association and the Marin County Employees Retirement Association. Marin County's defined benefit plan benefits include an ongoing COLA; Sonoma County's plan does not. I was elected four times to serve on Sonoma County's retirement board; and served on the Marin County retirement board when the Marin County Board of Supervisors selected me as their first Director of Finance, to consolidate the offices of Treasurer-Tax Collector, Auditor-Controller and Public Administrator.

My experience with government finance, budget, accounting and retirement system funding policies spans over 30 years; and includes government employment in Sonoma and Marin counties, and private sector client services delivered as a practicing CPA.

For Sonoma County, I worked as an Accountant I (Sheriff's Office); staff auditor; budget analyst (CAO); Assistant Auditor-Controller, and Information Systems Director. For Marin County I worked as the Director of Finance. In the private sector, I worked for Brion Economics, LLC, performing comparative fiscal analysis of cities and counties.

In my CPA practice, I've conducted fiscal health assessments for and consulted on retirement funding alternatives for city clients. For labor groups, I have performed financial analysis of information in support of negotiations and preparation for fact finding.

I am thankful and honored to have worked with great government employees in Sonoma County.

SCERA Elections continued

Neil Baker — You won't get a ballot for the alternate position as Neil is running unopposed. We thought our members would still be interested in his background. "I have represented SCERA and its members for over 40 years, both as an employee and a retiree. For much of that time I was the legal counsel and, since 2015, I have served as the 8th Alternate Member. I think this is an especially important period for SCERA. A process is underway to evaluate a possible retiree cost-of-living-adjustment and I am a member of the subcommittee that has been established to work on that issue. Ultimately, only the County can make a final decision regarding such a benefit. However, SCERA can play a significant role and I believe that because of my background and experience I can make a substantial contribution to this process".

Summary of the American Red Cross Presentation at the August Membership Meeting

Vincent Valenzuela, the Disaster Program Manager for Sonoma, Solano and Napa, provided information on the various services provided by the American Red Cross (ARC). It provides services locally, across the country and around the world. Major service categories include Disaster Cycle Services, Biomedical Services, Service to the Armed Forces, International Services and Training Services. They received no government funding – all funding comes from donations. Some interesting facts:

90% of the money donated to them goes for services.

90% of the work force is volunteer.

They work with local agencies to develop plans for dealing with disasters.

They respond to both large disasters and loss of individual homes. ARC volunteers go house to house after a disaster to see what damage was done and what is needed.

They provided support for 81 large disasters occurring from Jan. – March 2023 with 22 being very large disasters in the U.S.

They provide emergency response training programs for kids.

Install home smoke alarms and assist with fire escape plans.

They provide more blood than any other blood bank with donations averaging 12,000/day.

They provide 400,000 measles or rubella vaccination worldwide working with partners.

Provided training in first aid, CPR, AED, swim and lifeguard classes, and emergency preparedness to over 5 million people in 2022.

ICPC met on October 5th and continued to educate new members. Julie Wyne went through a number of SCERA reports explaining and discussing many aspects of them. Next session is set for December 7th, and will be focused on debriefing from the SCERA annual planning retreat and the preparation of the annual Report to the BOS on the pension.

I thought many retirees might not be familiar with the North Bay Labor Council (NBLC). It is one of nearly 500 state and local labor councils acting as an arm of the AFL-CIO. Labor Councils are the heart of the labor movement. NBLC represents over 70 thousand working people and some 70 union affiliates in Sonoma, Lake, Mendocino, and Marin Counties. The Labor Council is a democratically elected body dedicated to represent the interests of working people at the state and local level. We mobilize our members and community partners to advocate for social and economic justice. NBLC works to elect candidates to public office who support Labor Standards and will stand by working people. The North Bay Labor Council strives daily to vanquish oppression and make our communities better for all people—regardless of race, color, gender, religion, age, sexual orientation, immigration status, ethnic or national origin.

Stay Safe from Scams

We know a lot of our members bank with Redwood Credit Union. One of our members recently received a call that she thought was from Redwood Credit Union telling her that her account had been hacked and asking her to withdraw money. She went to her bank and was told they did not contact her although the part about her computer being hacked was taken seriously. I wondered how an impostor got her account number, so I went to my local branch and talked to the manager. Several incidents like the above have been reported recently - this was not an isolated case. The manager's primary message was 'IF SOMEONE SAYING THEY ARE FROM RCU CONTACTS YOU BY PHONE OR EMAIL AND ASKS YOU FOR ANY INFORMATION ON YOUR ACCOUNT, IMMEDIATELY HANG UP AND CALL RCU AT 707-545-4000. This applies to any other bank, credit card company or IRS. **Do not give out your private information.**

Redwood Credit union then provided us with the following information on avoiding current scams.

Redwood Credit Union serves to elevate your financial well-being and help protect the financial well-being of our entire community. Scams and fraud are on the rise, and we're committed to helping you protect yourself. Here are the most common ways scammers try to get your private information and what you should do:

Spoofed Calls

Scammers can manipulate a phone call to look like it's coming from a reputable source, such as a financial institution, law enforcement, IRS, utility companies, and other business or professional organizations.

If someone calls you claiming to be from a business or organization and you have any doubt, hang up and call the verified customer service number. Or simply JUST HANG UP!

Phishing Emails

Scammers will send emails that appear to be from reputable source or reliable organizations. Don't click any suspicious links and don't give your info to anyone who contacts you out of the blue.

Legitimate organizations never call, email, or text to ask for your account or personal information.

Wire Fraud

Scammers often pressure you to wire money to them because wire transfers are final transactions and are very difficult to reverse.

Never send a wire to a new recipient without due diligence and never wire money to a stranger or someone you have just met, no matter the reason.

You should report wire fraud to the FBI at www.ic3.gov

Romance Scams

Scammers will often try to rush a new relationship, but refuse to video chat or meet you in person.

Be cautious of anyone who claims they will provide for you while in a relationship with them. Don't provide credit or debit card, or account information to a person with whom you are in a new relationship.

Never send money to an online-only romance, don't accept deposits from them, and never make purchases for them.

How to protect yourself from identity theft:

If your information is stolen, credit freezes and fraud alerts can protect you from identity theft and prevent further misuse of your personal information.

Credit monitoring services can contact you immediately if someone were to attempt to open a credit card or take out a loan in your name.

Ways of preventing against child identity theft:

Child identity theft is happening more frequently, so children's credit checks should be conducted once a year. These checks can be done for free at AnnualCreditReport.com

For children under 16, you can request a free credit freeze to make it harder for someone to open new accounts in your child's name.

A credit freeze will remain in place until the parent or guardian advises the credit bureaus to remove it. Minors who are 16 or 17 can request and remove a security freeze themselves.

Tackling the Opioid Crisis Head-On in Sonoma County

The opioid overdose epidemic stands as a towering crisis of our times, leaving trails of tragedy across the nation and our close-knit community in Sonoma County. Since 1999, the haunting tally of lives lost to drug overdoses across the United States has surged past one million. The grim statistics show a disturbing acceleration in fatal overdoses, with 2021 witnessing 106,699 heartbreaking deaths. Among these, opioids cast a long, grim shadow, implicated in 75% of the losses. Additionally older Americans have not been spared; deaths for people 65 and older rose 50% between 2019 and 2021.

In Sonoma County, the crisis claims its harsh toll. In 2021, the community mourned the loss of 122 cherished lives — mothers, fathers, siblings, friends leaving behind voids that no words can fill. Our community grapples with the third-highest per capita rate of fatal fentanyl overdoses in California, trailing only Mendocino and San Francisco counties.

Opioids, potent in pain management, come with a menacing duality. They span prescription forms like hydrocodone, oxycodone, and fentanyl, but also mask in illicit avatars, leaving a trail of devastation. Fentanyl, a synthetic opioid 100 times more potent than morphine and 50 times more potent than heroin, emerges as the dark protagonist in the saga, causing a staggering 88% of opioid-related fatalities in 2021, a devastating loss of 70,762 lives.

This formidable adversary is deceptive in its potency, lacing supplies unbeknownst to users, and striking with lethal force. Fentanyl, despite not being the preferred choice for many, lurks ominously in the shadows of the opioid supply chain due to its chilling efficiency and terrifying strength. Illicit fentanyl has permeated the drug supply because of its remarkably low cost and potent nature, which facilitates easier smuggling.

Face 2 Face: A Beacon of Hope and Support

In 1983, in the crucible of the HIV/AIDS crisis, Face 2 Face was born as a beacon of hope. Over decades, it has woven a tapestry of community support, prevention, education, and compassionate case management to address numerous public health issues in partnership with many organizations, including Sonoma County's Department of Public Health, and the Santa Rosa Treatment Program (SRTP).

Embracing evolution to meet the urgent calls of the community, Face 2 Face expanded its arms in 2015, introducing the syringe service program rooted in harm reduction. This initiative, extends a lifeline to those in the shadows, offering syringes, testing for HIV/HEP C, and vital supplies like Narcan and fentanyl test strips, forging paths to safety and care.

Narcan stands as a guardian in the opioid crisis, a swift responder to reverse overdoses, breathing life back into fading hopes. At Face 2 Face, the doors stand open, welcoming all with a promise of help, guidance, and free access to Narcan, along with essential training in the administering of Narcan.

Do It Yourself (DIY) Energy and Water Savings Toolkits are available for checkout at all branches of the Sonoma County Library

The Toolkits include the tools and information necessary for customers to perform their own home upgrade projects to weather strip windows and doors, monitor electrical usage, find water leaks and make their homes more efficient with LED lightbulbs. There are several things that you can keep — low flow aerators for bathroom and kitchen faucets; low flow showerheads (2); LED lightbulbs, and more. Sonoma County Library cardholders can check out the kits for up to three (3) weeks.
